**Notes:**

- 1) Super Shakti women's account holders shall be eligible for 25% discount on the annual locker rent for Small Lockers only. Initially there will be no rebate in rent. If the customer maintains AQB of Rs 5,000 for the year then the rebate will be applicable and customers account will be credited with discounted portion at the end of financial year.
- 2) Jubilee Plus account holders shall be eligible for 25% discount on the annual locker rent for Small Lockers Only. Initially there will be no rebate in rent. If the customer maintains AQB of Rs 5,000 for the year then the rebate will be applicable and customers account will be credited with discounted portion at the end of financial year.
- 3) Preferred Account customers shall be eligible for 50% discount on the annual locker rent. Initially rebate of 50% in rent will be given with intimation that in case of non maintenance of AQB / FD the rebate would be recovered.
- 4) IDBI Royale: Small size locker free (Exclusive of Admin charges) or 50% discount on other locker sizes
- 5) Power Plus account shall be eligible for 25% discount on the annual locker rent on all lockers.
- 6) Administrative Charges and other related charges needs to be collected.

\* A category as per LMS will be considered as small locker.
